

“Dine On Us” PROMOTION
TERMS AND CONDITIONS

1. Information on how to enter and the gift(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is The Trustee for KAHl Altone Trust trading as Altone Park Shopping Centre (ABN 80 852 574 265) of 161 Altone Road, Beechboro WA 6063 AUSTRALIA 08 9418 1655 (“**Promoter**”).
3. Entry is only open to Australian residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoter, tenants and their employees, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
5. Promotion commences on Thursday 27 March 2025 and ends at 3.00pm AWST on Sunday 30 March 2025 (“**Promotional Period**”).

 - b. retain your receipt(s) as proof of purchase;
 - c. visit the redemption booth located near Woolworths during the Promotional Period and during the hours of Thursday – Saturday, 10am – 3pm and Sunday, 11am – 3pm;
 - d. present your receipt(s) to the promotional staff;
 - e. sign up to the Altone Park email database.

8. The following receipts are not accepted as part of the Promotion:
 - a. receipts from bill payments such as the payment of credit card bills, ATM or bank transactions, bank fees and charges, service bills (such as gas, electricity, rates and phone bills), cash advances/withdrawals, account charges, government fees and interest charges;

9. You must keep your original itemised purchase receipt(s) as proof of purchase for all entries.

Your purchase receipt/s must clearly identify where the Qualifying Spend was made, the product/s purchased (which must be/comprise the Qualifying Spend) and the date of purchase (which must be during the Promotional Period before you submitted your entry).

If, in the Promoter's opinion, you have shared any proof of purchase with another person, your entries will be invalid and you will lose any right to a gift.

10. Incomplete, indecipherable, or illegible entries will be deemed invalid.
11. Receipts can be combined to reach the Qualifying Spend requirement, subject to a) each receipt is in accordance with entry requirements; b) receipt(s) can only be presented once to claim a gift; c) original receipt is presented; d) the value of a receipt cannot be split to obtain another gift.

13. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or gift claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking/use of a gift.
24. As a condition of accepting a gift, each winner must sign any legal documentation as and in the form required by the Promoter and/or gift suppliers in their absolute discretion, including but not limited to a legal release and indemnity form.
